

Before the release, these reptiles, classified as tortoises, were surrendered to the Community Environment and Natural Resources (CENR) Offices of Alcala and Solana.

They were temporarily turned over to the Rogelio B. Baggayan Nature Park and Wildlife Center in Tuguegarao City, a temporary shelter for confiscated or surrendered wildlife, for proper
